That on, about, or between the 1st day of August, 2017 and the 5th day of September, 2017, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully, feloniously, intentionally and with premeditation agree with another person, to-wit: Alan Alanis and/or Jovan Pecina and/or Andrew John Granado and/or Armando Nunez and/or Jordy Cornejo Campoverde, to commit or assist in the commission of the crime of First Degree Murder, to-wit: killing a human being, to-wit: Jesus Avila Jr, and an overt act, to-wit: Samuel Garcia obtained a .22 caliber pistol; Andrew John Granado, Samuel Garcia, Jovan Pecina, Alan Alanis, Armando Nunez and Jordy Cornejo Campoverde communicated through social media applications and/or electronic devices to aid in the commission of the crime; Andrew John Granado, Samuel Garcia, Jovan Pecina, Alan Alanis, Armando Nunez and Jordy Cornejo Campoverde skipped school and met at Cornejo Campoverde's house; Samuel Garcia contacted Jesus Avila, Jr.; Samuel Garcia and Jovan Pecina left with Jesus Avila, Jr. in Avila's vehicle; Samuel Garcia shot and killed Jesus Avila, Jr.; Andrew John Granado drove himself, Alan Alanis, Armando Nunez and Jordy Cornejo Campoverde and took gasoline to a predesignated location where they met Samuel Garcia and Jovan Pecina, with Avila's vehicle and body; Andrew John Granado and/or Samuel Garcia and/or Jovan Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo Campoverde removed U.S. currency, a speaker, and an AK47 rifle from Avila's vehicle, Andrew John Granado and/or Samuel Garcia and/or Jovan Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo Campoverde burned Avila's vehicle and body using the gasoline provided; Andrew John Granado drove Samuel Garcia, Alan Alanis, Armando Nunez, Jovan Pecina and Jordy Cornejo Campoverde back to Cornejo Campoverde's house; Samuel Garcia, Alan Alanis and Jordy Cornejo Campoverde disposed of the .22 caliber pistol; Andrew John Granado and/or Samuel Garcia and/or Jovan Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo Campoverde distributed the U.S. currency amongst themselves and concealed the speaker and AK47 rifle, in furtherance of the conspiracy was committed by Andrew John Granado and/or Samuel Garcia and/or Jovan Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo-Campoverde. In violation of K.S.A. 21-5302 and K.S.A. 21-5402 (a) (1), and against the peace and dignity of the State of Kansas (Severity Level 2 Person Felony) [21.5402.a.1/con]

# Count 2 - Murder in the 1st degree; Intentional and premeditated

That on or about the 5th day of September, 2017, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully, feloniously, intentionally and with premeditation, kill a human being, to-wit: Jesus Avila Jr. In violation of K.S.A. 2-5402, and against the peace and dignity of the State of Kansas. (Off-grid Person Felony) [21.5402,a.1]

# Count 2 - Murder in the 1st degree; In the commission of a felony

That on or about the 5th day of September, 2017, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully and feloniously kill a human being, to-wit: Jesus Avila Jr, during the commission of, attempt to commit, or flight from the commission of an inherently dangerous felony, to-wit: Aggravated Robbery as defined in K.S.A. 21-5420(b) and amendments thereto. In violation of K.S.A. 21-5402, and against the peace and dignity of the State of Kansas. (Off-grid Person Felony) [21.5402.a.2]

# Count 3 - Conspiracy aggravated robbery; Armed w/ dangerous weapon

That on or between the 1st day of August, 2017 and the 5th day of September, 2017, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully, feloniously and knowingly, agree with another person, to-wit: Alan Alanis and/or Jovan Pecina and/or Andrew John Granado and/or Armando Nunez, and/or Jordy Cornejo-Campoverde, to commit or assist in the commission of the crime of Aggravated Robbery, while armed with a dangerous weapon, to-wit: a .22 caliber pistol, to take property, to-wit: US currency, AK47 rifle, speaker, and/or Nissan Altima vehicle, from the person or presence of Jesus Avila Jr, by force, or by threat of bodily harm to any person, and an overt act, to-wit: Samuel Garcia obtained a .22 caliber pistol; Andrew John Granado, Samuel Garcia, Jovan Pecina, Alan Alanis, Armando Nunez and Jordy Cornejo Campoverde communicated through social media applications and/or electronic devices to aid in the commission of the crime; Andrew John Granado, Samuel Garcia, Jovan Pecina, Alan Alanis, Armando Nunez and Jordy Cornejo-Campoverde skipped school and met at Cornejo Campoverde's house; Samuel Garcia contacted Jesus Avila, Jr.; Samuel Garcia and Jovan Pecina left with Jesus Avila, Jr. in Avila's vehicle; Samuel Garcia shot and killed Jesus Avila, Jr.; Andrew John Granado drove himself, Alan Alanis, Armando Nunez and Jordy Cornejo Campoverde and took gasoline to a predesignated location where they met Samuel Garcia and Jovan Pecina with Avila's vehicle and body; Andrew John Granado and/or Samuel Garcia and/or Jovan Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo Campoverde removed U.S. currency, a speaker, and an AK47 rifle from Avila's vehicle, Andrew John Granado and/or Samuel Garcia and/or Jovan.Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo Campoverde burned Avila's vehicle and body using the gasoline provided; Andrew John Granado drove Samuel Garcia, Alan Alanis, Armando Nunez, Jovan Pecina and Jordy Cornejo Campoverde back to Cornejo Campoverde's house; Samuel Garcia, Alan Alanis and Jordy Cornejo Campoverde disposed of the .22 caliber pistol; Andrew John Granado and/or Samuel Garcia and/or Jovan Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo Campoverde distributed the U.S. currency amongst themselves and concealed the speaker and AK47 rifle, in furtherance of the conspiracy was committed by Andrew John Granado and/or Samuel Garcia and/or Jovan Pecina and/or Alan Alanis and/or Armando Nunez and/or Jordy Cornejo-Campoverde. # Count 4 - Aggravated robbery; Inflicts bodily harm

That on or about the 5th day of September, 2017, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully, feloniously and knowingly, take property to-wit: US Currency, AK47 rifle, speaker, and/or Nissan Altima vehicle, from the person or presence of Jesus Avila Jr, or by force, or by threat of bodily harm to any person, and during the course of such robbery, bodily harm was inflicted upon Jesus Avila Jr. In violation of K.S.A. 21-5420(b), and against the peace and dignity of the State of Kansas. (Severity Level 3 Person Felony) [21.5420.b.2]

#### OR IN THE ALTERNATIVE

### Count 4 - Theft of property or services; Value less than \$1,500

That on or about the 5th day of September, 2017, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully obtain or exert unauthorized control over property worth less than 1,500.00, to-wit: US currency, AK47 rifle, and/or speaker, with the intent to permanently deprive the owner, to-wit: Jesus Avila Jr, of the possession, use or benefit of such property. In violation of K.S.A. 21-5801(a)(1) & (b)(4), and against the peace and dignity of the State of Kansas. (Class A Nonperson Misdemeanor) [21.5801.a.1.b4]

# Count 5- Arson; Intentional to non-dwelling of another without consent

That on or about the 5th day of September, 2017, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully, feloniously, and knowingly damage by means of fire or explosive, property which is not a dwelling, to-wit: Nissan Altima vehicle, in which Jesus Avila Sr and/or Jesus Avila Jr have an interest and who did not consent to said damage. In violation of K.S.A. 21-5812(a)(1)(C), and against the peace and dignity of the State of Kansas. (Severity Level 7 Non-person Felony) [21.5812.a.1.C]

# Count 6 - Interference with LEO; Conceal/alter/destroy evidence

That on, about or between the 5th day of September, 2017 and the 3rd day of March, 2018, in Lyon County, Kansas, Samuel Garcia, then and there being present did unlawfully, feloniously and knowingly conceal, destroy or materially alter evidence with the intent to prevent or hinder the apprehension or prosecution of any person, and further said act was committed in the case of a felony. In violation of K.S.A. 21-5904(a)(2) & (b)(4)(B), and against the peace and dignity of the State of Kansas. (Severity Level 8 Non-person Felony) [21.5904.a2.b4.B]

Complainant requests the parent(s), if not already under court order to do so, be ordered to pay child support for said juvenile for any periods during which care, custody and control of the child is not vested with the parent(s).
